Dear Mr. Talley:

After careful review, we have decided that your registration with the Boy Scouts of America should be suspended. We are therefore compelled to request that you sever any relations that you may have with the Boy Scouts of America.

You should understand that BSA leadership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to suspend registration whenever there is a concern that an individual may not measure up to the high standards of leadership which the BSA seeks to provide for American youth. Please also understand that this decision and the reasons for it will be maintained as confidential.

If you wish to have this decision reviewed, please write to me, explaining your version of the facts supporting your claim that your registration as a BSA leader should be grated or reinstated.

MEETING FEBRUARY 21 1983 REGARDING NEAL TALLEY, SCOUTMASTER OF TROOP 278

Parents, Mr. and Mrs. [REDACTED] Yorkshire, 38119 and Mrs. [REDACTED] Cove, Memphis, Tn. 38115, called David Allen, Director of Field Service, alleging that Mr. Talley asked their sons (one a Scout and one visitor to strip naked and proceeded to wash them with alcohol and water touching genital parts of their sons.

They were asked to meet with Joe Long in the afternoon. Bill Fowler, former Scoutmaster of the Troop and presently Troop Committee Chairman, was called and asked to meet with Joe Long and David Allen prior to meeting with parents and the parents meeting.

Mr. Fowler's meeting was held and he stated that Mr. Talley had taught realistic first aid for years but had recently been registered as Scoutmaster.

MEETING - 4:30 P.M.:

Those present: Mr. and Mrs. [REDACTED] Mrs. [REDACTED], Bill Fowler, David Allen and Joe Long. 2 boys were asked to come and were left outside of first meeting. Mr. and Mrs. [REDACTED] stated that son [REDACTED] was asked to attend troop outing as a guest by friend [REDACTED]. They were taken on a weekend outing by 4 adults with 10-15 other Scouts to Kia Kima Scout Reservation. Mr. Talley came to tent and was asked if he would be a first aid victim to teach Scouts emergency first aid. Mr. Talley took son [REDACTED] to a secluded place while other Scouts took a hike. Mr. Talley proceeded to ask [REDACTED] to strip and sponged him with alcohol and water touching his penis two times. He was blindfolded with tape (Talley told him to keep alcohol from burning eyes). Mr. Talley placed realistic wounds on his head, thigh, and back. [REDACTED] was asked to put on old clothes and lay down by tree for other Scouts to find.

MRS. [REDACTED] stated that son [REDACTED] came home after Scout meeting in fall and told her that Mr. Talley had asked him to be first aid victim at next meeting. She thought nothing unusual of this. Mr. Talley asked [REDACTED] to shower good before Scout meeting so that first aid make-up would hold.

MEETING ON FEBRUARY 22, 1983

10 A.M.

Meeting was held at Reverend Jim Stanford's Office. Present at the meeting were: Rev. Stanford, Troop Committee Chairman Bill Fowler, Joe Long and Pat Currie from the Scout Office and Neal Talley. Joe Long gave Neal the letter and asked him to read it, which he did. After reading the letter, he questioned Joe on why he was being removed as Scoutmaster. Joe said that it was due to alleged actions unbecoming of a leader. When Neal pushed this further, Joe stated that the letter was final as far as we (the Boy Scouts of America) was concerned. Neal then stated that although he didn't understand why, that if this is what we wanted, then he would accept the letter. The meeting was adjourned and everyone left except Neal who stayed to talk with Reverend Stanford.

CONVERSATION WITH REVEREND STANFORD - 2 P.M. 2-22-83.

Reverend Stanford stated that he talked to Mr. Talley after we left. Talley questioned him as to why, but Reverend Stanford told him that this was to be held in confidence and if he had any further questions he should contact the Chickasaw Council. Rev. Stanford also indicated [REDACTED] had visited with his Assistant Pastor this morning and she was concerned that the man should get some help. Rev. Stanford indicated that he thought we should tell Mr. Talley why and that the parents of the boys felt that this suspension letter was not enough. Joe Long told Reverend Stanford that any further action was up to Mr. Talley and the parents.
