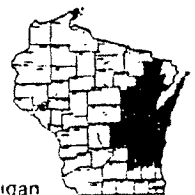

Appleton man guilty of sexual assaults

Sentencing has been set for 5 p.m. July 12 for a 42-year-old Appleton man after he pleaded no contest to six counts of sexual assault involving six children between the ages of 9 and 16.

Kenneth E. Williamson, 537 N. Lawe St., Appleton, entered the pleas and was found guilty this morning by Outagamie County Circuit Judge Gordon Myse. Five of the counts allege first degree sexual assault while the sixth was a second degree sexual assault. He was to stand trial on 12 counts of sexual assault on Monday.

He remains free on a \$1,500 signature bond. The offenses were alleged to have been committed between May 1977 and April 1981.
