
Dear Mr. Ernst,

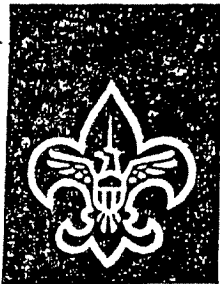
