Please also understand that this decision and the reasons for it will be maintained as confidential.

If you wish to have this decision reviewed, please write to us, explaining your version of the facts supporting your claim that your registration as a BSA leader should be reinstated.

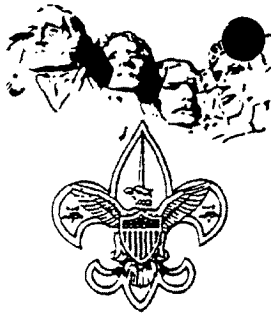

This statement is in support of the cross-examination I had with Scout Executive Gene Stone on Monday, August 5, 1985.

As leader & Scoutmaster of the 1985 Gumboose Troop 256 I was confided in by one of the Scout participants relative to an incident that occurred following a meeting of the Gumboose Troop in early July.

It was reported to me by the youth that he was given a ride to his home but someone was driven to a private house where Tom John Wilkins had sexual contact with the boy.

The youth approached me at a later date with this information & asked that I not tell his parents.

I felt it appropriate to confidentially advise the adult volunteer from leadership responsible with the Gumboose & subsequently report this upon arrival home following the Gumboose

Phone Conversation with Dr. Dennis Wicks of Custer, SD August 7, 1985

Dr. Wicks, Council Board Member and Physician in Custer, SD visited the boy involved in the incident described in [REDACTED] letter. During the visit, the sexual contact was confirmed.

Dr. Wicks offered open communication and assistance to the boy if and when desired. Initial reaction is that boy is dealing well with the situation.

Dr. Wicks will continue to monitor the situation.

In a conversation with Mr. John Webner he admitted at least one contact in a sexual manner with a youth member. He did not disclose name or date of activity.

He expressed remorse at having "made a mistake". He hoped his "mistake" would not lead to a curtailment of Scouting as this activity was very important to him.

I recommended that Mr. Webner seek professional counseling and asked him to call me regarding a time we could meet the following day.

He called and set an appointment for August 7, at 11:00 AM. I secured a written statement from [REDACTED], contacted the Council Attorney, and Council President.

A letter of suspension was prepared for presentation at the meeting on August 7, 1985.

The following information was verbally provided to John D. Webner on August 7, 1985. This information was given in support of attached letter suspending registration as a volunteer leader.

The Council has been provided information and evidence - including your personal discussion with the Scout Executive involving "Sexual Experimentation" to convince it that your moral life does not meet the standards for leadership in the Boy Scouts of America.

Information indicates contact of a sexual manner with 1 or more Scouts/Youth.

The Boy Scouts of America is not sharing this information with anyone and only wishes you to stop All scouting activity.

If you decide to seek reversal of this decision, you are entitled to review proceedings. First, by the local Council, then by the Region, then by the National Council. Your request must be in the form of a written report including your version of the facts supporting the claim that registration should not be denied.

Mr. Webner asked if any Scouting activity would be allowed - he was told that as per the letter, all activity must stop. This included visits to camp, activities, etc.

Mr. Webner expressed his personal "hurt" involved with the situation and resentment at not being able to participate in scouting. He expressed repeatedly that he was being penalized for a mistake.
