Sentencing Nets Two-Year Parole

REXBURG — James Vetro, 26, Roberts, was sentenced to two years probation on a felony count of lewd and lascivious conduct by District Judge Willard C. Burton Friday. Vetro had earlier pleaded guilty to the charge. The probation terms are in lieu of a withheld judgment.

Vetro was charged with molesting an 11-year-old boy on Dec. 30, 1971. He had been free on \$5 thousand bond and a trial was scheduled prior to his entry of a guilty plea.
