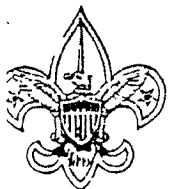

I got scared and jumped out of the sleeping bag and stayed up by the fire all night. I guess he got mad cause he got up and said he was going to a movie in town and left us alone most of the night.

So we would appreciate it if you would look into it before he hurts some poor kid.
