This information will enable us to identify Mr. Pilkington, should he ever again attempt to register in the Scouting program.

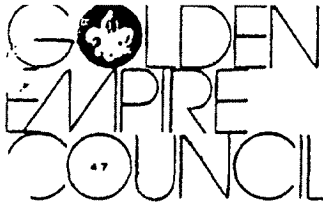

# Sex-Offender's Advice: 'Don't Be Hitchhiking'

Two Sacramento boys, ages 16 and 13, received some belated advice on the pitfalls of hitchhiking from their would-be benefactor last Dec. 28.

The cousins made the mistake of climbing into the wrong car that stopped to pick them up at 16th and J streets.

Instead of a ride home, they were taken to a deserted area, handcuffed together at gunpoint and forced to disrobe and submit to attempted sexual activity.

But a passing sheriff's deputy brought the unusual night to

an end at East Levee Road, south of Elkhorn Boulevard.

It ended with the capture and shooting of Gregory Alan Pilkington, 23, of 7607 Vasos Way, Fair Oaks.

Pilkington, a store clerk and former Boy Scoutmaster, told the officers, "I didn't mean to do it; please let me die."

In subsequent court proceedings, Pilkington after an unsuccessful apparent suicide attempt at the hospital, pleaded guilty to a charge of forcible sex perversion.

Superior Court Judge Robert

K. Puglia dismissed five other counts, including two of kidnapping, and on the basis of psychiatric reports ruled Pilkington was a mentally disordered sex offender.

Pilkington was ordered committed to Astascadero State Hospital last week for treatment.

After his arrest, Pilkington told officers, "Please call those kids and tell them not to be hitchhiking again.

"There are too many weird people like me around."

## Three Are Committed As Sex Offenders

Gregory A. Pilkington and two others were committed to Atascadero State Hospital as mentally disordered sex offenders.

Superior Court Judge Robert K. Puglia ordered Pilkington and Clarence L. Williams to the hospital after receiving reports from court-appointed physicians recommending this action.

Pilkington was picked up Dec. 28 after sexually assaulting one of two teen-aged boys he picked up at 16th and J Streets. Pilkington left the two

boys handcuffed together in an open field in North Highlands but their cries for help were heard by a passing sheriff's patrol unit who also spotted Pilkington's car leaving the scene.

Williams was arrested in January on a child molesting charge at his shoe store on Marysville Boulevard.

The third person, Charles D. Fichter, was sent to Atascadero by Superior Court Judge Robert W. Cole after admitting he molested two girls he was babysitting last Dec. 26.
