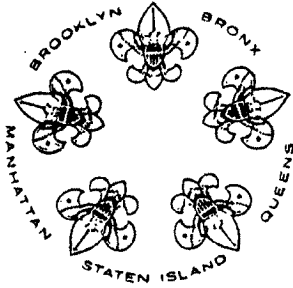

This will acknowledge receipt of your letter dated December 5, 1973, relative to the disposition of the above captioned indictments.

Please be advised that the defendant, Fred Modica, was indicted under the above captioned indictments for numerous counts involving Sodomy, Sexual Abuse, Sexual Misconduct and Endangering the Welfare of a Child, and that on September 10, 1973, the defendant pleaded guilty under Indictment #3257/1973 to the crime of Attempted Sodomy in the First Degree (a Class C Felony) before Mr. Justice David Epstein, to cover all counts of both indictments. He is presently awaiting sentence.
