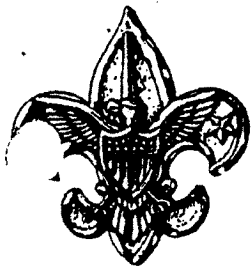

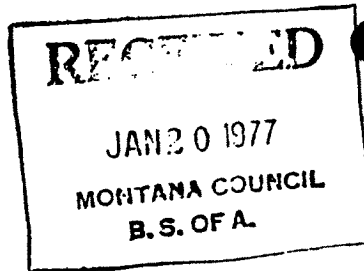

Dear Mr. Hanawalt:

In response to your request for criminal history information pertaining to the above referenced subject as referred to me verbally by Art Sward in Kalispell, I am able to comply with only part of your request. After referring to Title 28, Chapter 1, Part 20, Subparts A & B of United States Code, I find that I am unable in any fashion to disseminate information concerning positive identification of John David McBride (date of birth, social security number, physical description, other identifying data). I am able to relay public information concerning McBride's arrest and the subsequent disposition of the charges against him. However, please be advised that THE FOLLOWING INFORMATION AS IT PERTAINS TO CRIMINAL CHARGES AGAINST JOHN DAVID MCBRIDE IS DISSEMINATED TO YOU FOR THE SOLE PURPOSE OF USE BY THE BOY SCOUTS OF AMERICA IN THEIR DETERMINATION OF HIS FITNESS AS A MEMBER OF THAT ORGANIZATION.

1. (11/21/74) A warrant of arrest was issued in Lincoln County, Montana for John David McBride charging him with the crime of deviate sexual conduct, two counts, felonies, in violation of Section 94-5-505 of the revised codes of Montana.
2. The above mentioned warrant of arrest was served on John David McBride on the same date.
3. (11/26/74) John David McBride was arraigned before 11th Judicial District Court Judge Robert S. Keller on an amended information charging him with six counts, felonies, of lewd and lascivious acts upon a child, and eleven counts, felonies, of deviate sexual conduct without consent. At that time the defendant pled not guilty.
4. (2/10/75) John David McBride appeared before 11th Judicial District Court Judge Robert S. Keller and changed his plea to guilty on 15 of the 17 felony counts against him. The remaining two counts were dismissed.



5. (2/10/75) After accepting the plea of guilty on 15 felony counts, Judge Keller sentenced the defendant John David McBride to a three year deferral of sentence under certain conditions "including further treatment with Dr. Kuska and placed under the jurisdiction of the State Board of Pardons."

I hope this information is satisfactory for BSA requirements. Further information regarding the specific counts charged against McBride, etc., are on file with the Lincoln County Clerk of Court, Courthouse, Libby, MT, 59923. If I can be of any further assistance to you in this matter please do not hesitate to contact me.
