Man charged with having sex with two boys

A man who allegedly enticed juvenile boys to his home by showing them movies and video games was charged Wednesday with having sex with two boys.

[REDACTED], 34, a former Cub Scout leader who also took part in youth sports programs, faces three counts of third-degree criminal sexual conduct, according to a complaint filed yesterday in Hennepin County District Court. One count was for allegedly having oral sex with a 14-year-old boy. He also was charged with twice having oral sex with a 15-year-old.

The sex acts occurred in [REDACTED]'s home, the complaint said.

Police searched his home, 1037 SE. 24th Av., Monday after checking reports about sexual activity there involving juveniles. The initial report came from a man whose son told him that an older son "was running around with [REDACTED]" and that the younger son "had been asked by Mr. [REDACTED] to view X-rated films," the complaint said.

The father had talked to other boys in the neighborhood and found that many had been staying [REDACTED] home on weekends, and that sex acts were possibly being committed with juveniles, the complaint said.

Police found a suitcase full of photographs showing nude young boys and several pictures of [REDACTED] engaged in sex acts with young boys, the complaint said. Sgt. Phil Bishman, family violence investigator, said at least 200 pictures were found, many of them taken through a one-way mirror.

[REDACTED] formerly lived in San Francisco, where some of the pictures reportedly were taken, police said. Bishman said he is not sure how many of the youths in the pictures are from the Twin Cities. Five have been identified to date, he said.

"There is no reason to believe any of his team members were involved," Bishman said yesterday. [REDACTED] has known some of the boys for at least two years, he said. Those involved are from northeast Minneapolis.

[REDACTED] befriended many of the boys after meeting them through other boys, according to an affidavit filed yesterday in district court. An inventory list filed with the affidavit said police found a camera, five rolls of undeveloped film, an artificial sexual device, and pictures of boy scouts and an athletic team.

"Most of the kids came over to watch movies; he had all kinds of movies, just stacks of them," Bishman said. "Ninety-five percent of them were decent movies." The remainder were X-rated, including "Deep Throat" and "Devil in Miss Jones," Bishman said.

Police are continuing to investigate Stachowski's alleged involvement with other youths in the pictures. Stachowski was arrested Monday night. He was being held in Hennepin County Jail. He is expected to make his first court appearance at 9 a.m. today. The complaint asks that bail be set at \$20,000.

The investigation apparently is unrelated to a similar case involving Terrill Allen Hansen, a South High School teacher, and Patrick Henry Cain. They were charged last week with first-degree criminal sexual conduct and the promotion of minors to engage in obscene works. Arrest warrants have been issued for both men. Minneapolis man, 34, charged in child-porn case

A 34-year-old Minneapolis man, who was a Cub Scout leader, coached youth sports and was praised by neighbors for his friendliness to children, was charged Monday with criminal sexual conduct involving juveniles.

A suitcase filled with pornographic photographs of young boys, pictures of the man performing sex acts with youths, a two-way mirror in the bathroom and sexual paraphernalia were found in the home of Michael Jerome Stachowski, 1037 24th Ave. S.E., Minneapolis, according to Police Sgt. Phil Bishman and to a complaint filed in Hennepin County District Court Wednesday.

Stachowski was charged with having sexual relations with two 15-year-old boys on at least three separate occasions.

MINNEAPOLIS POLICE began investigating Stachowski last Friday after a parent called police to say that his 12-year-old son had been asked by Stachowski to view pornographic films.

The parent questioned other boys in the neighborhood and found that several boys had been staying over there on weekends and that possibly sex acts were going on in the defendant's home," according to the complaint.

Police immediately began interviewing youths who knew Stachowski and obtained a warrant to search his home, Bishman said. Police searched the house Monday and took the photographs, films and paraphernalia as evidence. Stachowski, who manages Moen Photo Service, 2220 Central Ave. N.E., Minneapolis, was arrested Monday and is being held in the Hennepin County Jail.

Stachowski, who lived alone, allegedly offered money for nude photographs, showed the boys pornographic literature and transported boys in a van to his home, according to the application for a search warrant. Stachowski would meet young boys through other youths he had befriended, the application said.

Stachowski has no previous criminal record, Bishman said. The investigation is

continuing.

While filing the complaint Wednesday, Bishman emphasized the importance of parents being more aware of what their children do and who they spend their time with.

"Most parents don't know where their kids are spending their weekend," he said.

BISHMAN SAID it appeared that youths had been "coaxed" to the house and not physically forced. Stachowski apparently courted them with games and gifts, Bishman said. Sexual books were found in the bathroom and there was a two-way mirror so youths could be photographed unknowingly, he said.

The operation had been going on at least two years, he said.

Stachowski had done a variety of volunteer work with youths including being a Cub Scout leader in Blaine in the past year. He also coached local youth sports teams.

Neighbors praised Stachowski before hearing about the arrest and those that had heard were astonished.

"I'm totally shocked," said a Minneapolis man who knew Stachowski through his baseball coaching of 12- and 13-year-old boys. "I've known the guy for a long time. Everything seemed to be OK."

"He seems to be working with children a lot," one neighbor said, before learning of the arrest. "He has lots of electronic games and keeps the kids entertained. I give him credit for that."

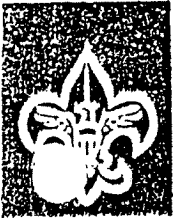
"He's a good neighbor," another woman said. "He's very active with youngsters in sports."

Another neighbor called him "a nice guy" who golfs, owns a home and has youths around his house.

Last week, a 33-year-old Minneapolis teacher was being sought on charges of first-degree criminal sexual conduct and promoting minors to engage in obscene acts.

Terrill Allen Hanson, a South High School teacher, and another man were accused of producing pornographic photos, films and video tapes of boys 12 to 16 years old and using boys as homosexual prostitutes.
