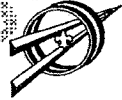

At your request we wish to submit the following statement pertaining to an incident involving our Scout Troop during our annual encampment at Camp Steere, July 10-16, 1966.

Several of our scouts, on returning from camp, reported that the Assistant Scoutmaster, Mr. Marion E. McCullough, showed some of the boys copies of nudist magazines as well as photographs of nude men and women posed in abnormal sexual activity. It was also reported that Mr. McCullough, after showing these photographs, made improper advances to one of our scouts.


Mr. McCullough was called in and informed of the aforementioned reports. He did not readily admit to these incidents but when one of the boys who was involved confronted him with his testimony, Mr. McCullough then admitted and confessed his guilt. He was requested to surrender his leadership with our Troop immediately.

Mr. McCullough volunteered to seek psychiatric help. He recently stated to our Scoutmaster that he had seen a psychiatrist on four occasions.
