Your letter dated December 3 addressed to Jack Rhea concerning James Francis West, formerly registered as Scoutmaster of Troop 27, has been referred to me for reply since our Service handles situations of this nature.

We have placed the information you provided in our files and have taken steps to have Mr. West's name deleted from the Troop roster. However, we really should have more information regarding this situation. Although your letter states West was picked up and booked on two charges of sodomy, what are the facts? What actually happened? What incident or situation occurred to cause his being picked up and booked? We would very much appreciate your writing us a more detailed letter giving us as complete a report as possible, together with forwarding to us any substantiating documents that might be available, such as copy of police report, court records, or any newspaper clippings.

Enclosed is a confidential record sheet which we would also appreciate your filling out and returning to us as soon as possible, together with the above requested information. This additional information will enable us to identify this individual should he ever again attempt to register in the Scouting program. Thanks for your help.

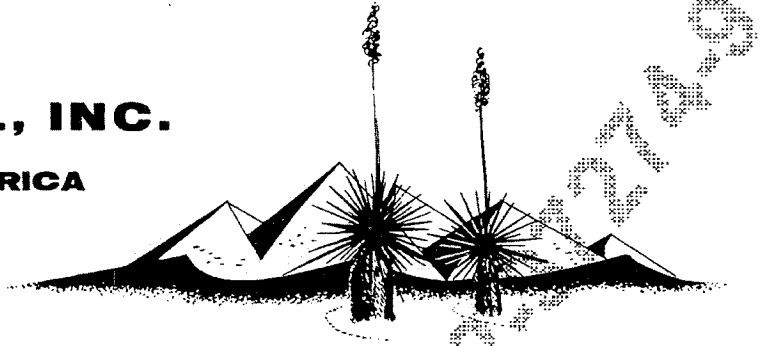

Please remove from your records the name of James Francis West, formerly Scout Master, Troop 27 in this Council.


He was recently picked up and booked on two charges of sodomy.
