Henry Cecil Ingling Jr., 3036 Linda Vista Ave., an employe of Sonoma State Hospital and former Scout leader, was released on \$2,750 bail and told to appear in Napa County Superior Court on Wednesday, Nov. 24, on charges involving young boys.

Dear Mr. Wilson:

Mr. Harry Cecil Ingling, Jr., 3063 Linda Vista Avenue, Napa, California, Scoutmaster of Boy Scout Troop 96 of this Council, was arrested yesterday on charges of lewd and lascivious conduct, perversion and sodomy, involving at least six boys. The arrest was made by Napa police, and he has been released on \$2,750 bail, pending a hearing to be held shortly.

We are working with the sponsoring institution and its Troop Committee in removing Mr. Ingling from his position as Scoutmaster, and are separating him from our registration rolls.

We respectfully request that you take necessary steps to place his name in the Confidential file and to cancel his National registration.

The newspaper story that publicized the case did not mention that Mr. Ingling was a Scoutmaster, and we are doing all we can to handle the matter efficiently and quietly.
