The enclosed photocopy of the Confidential Inquiry has been sent to your office by George Holland, former Scout executive of the Alamo Area Council. (date unknown)

The subject, John Stewart, Sr., was not allowed to register in Scouting upon advise of your office according to council records.

District Executive, Charles Glade of the Alamo Area Council inquired of me if John Stewart, Sr. could ever be registered in Scouting. Glade stated that the committee leadership of a local unit along with the head of the sponsoring institution had asked this man Stewart to serve as a unit committeeman and that he had signed the charter application. Glade further stated that Stewart had been active with the unit in 1968 although he was not registered.

I told Glade I would write you inquiring if John Stewart has been permanently placed on the confidential file listing, or if there is a possibility of his name being removed from the confidential file and allow him to register in an adult capacity with Scouting.
