We have, therefore, entered the name on our files in several different configurations to make certain that this "slip" of allowing a registration to get through the system does not again occur.

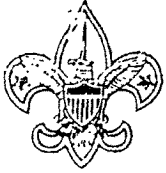

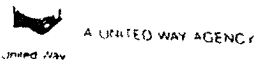

We reserve the right to suspend registration whenever there is a concern that an individual may not measure up to the high standards of leadership which BSA seeks to provide for American youth. Please also understand that this decision and the reasons for it will be maintained as confidential.

If you wish to have this decision reviewed, please write to me, explaining your version of the facts supporting your claim that your registration as a BSA leader should be reinstated.


Dear Paul:

I am sorry that I cannot provide you with "a copy of the police or court record, newspaper clippings and signed statements from individuals involved" ...regarding Ronald A. St. Laurent.

Acting on information from a reliable source, as Scout Executive of the Heart of America Council, I took the following action. I invited Mr. St. Laurent to my office and with a witness present told him that we could not accept his registration in the Boy Scouts of America. I returned his registration fee and tore up his application in front of him. At the same time I informed him that we had information that I was not at liberty to disclose that caused us to take such action. I likewise informed him that he could only secure the information by getting an attorney. At that point he confessed that he had a bad record, in fact, he told us what had happened while in the military and there is no question that he must be kept out of Scouting.

I realize that we live in a day and age where you cannot go on hearsay, but I would also submit that we live in a day and age where police departments, government organization and/or individuals are going to protect themselves from any repercussion. Sorry I can't provide you with more information.

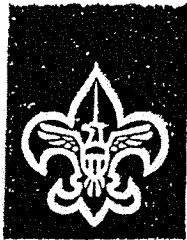
