## Former Judge Draws Maximum Sentence

A Kimble County jury Tuesday assessed the maximum penalty in two cases of child abuse.

William Mills, 42, a former Junction municipal judge, was sentenced to 99 years for aggravated sexual assault of a child and 20 years for indecency with a child, both terms to be served concurrently in the Texas Department of Corrections facility at Huntsville.

Mills pleaded guilty to both offenses during formal arraignment be-

fore 198th District Judge V. Murray Jordan.

The six man, six woman jury decided the punishment phase of the trial after only 40 minutes deliberation.

Defense attorney Charles Butts of San Antonio had asked for a probated sentence for his client. District Attorney Ron Sutton said Mills would have to earn 20 years credit before being eligible for parole.

## Arson Suspects Indicted

Grand jury for the 198th Judicial District Wednesday returned nine indictments against five men and one woman.

Joe Thomas Archer and Billy Wayne Dale have each been charged on two counts: arson and burglary of a building.

William Mills was also indicted on two counts, indecency with a child and aggravated sexual assault of a child.

Other indictments include Donald Eugene Hale, theft of livestock; John Yglesias, aggravated assault and Velma Sanchez, misapplication of funds by fiduciary.
