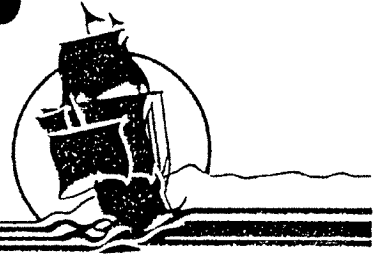

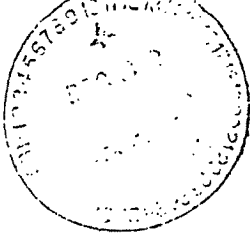

The following information is a summary of direct statements by [redacted] + [redacted] to the Council Executive + Field Director (11/30/82), and are identical to the statements made by [redacted] (age 10) during an personal interview by the Field Director (12/9/82).

[redacted] was attending Woodrow Camp (Aug 15-21, 1982) and Maurice Chappell was serving as a volunteer staff member.

"On the next to the last night Mr. Chappell entered the tent of [redacted] and asked: [redacted] if he was having trouble sleeping.

Mr. Chappell placed [redacted] hand on her lap + attempted to put his hand down the front of [redacted] pants. (P.S.) [redacted] immediately rolled over on her stomach. Mr. Chappell attempted it a second time + then left.

[redacted] said nothing until it came up in a conversation with her father on 11/27/82."

The above individual (Mr. Chappell) is currently not registered in any position within the Old Colony Council, or associated with any units or programs to the best of our knowledge.
