TO WHOM IT MAY CONCERN:

My son, [REDACTED] was invited by Tommy Lewis to spend the night after our Church's Christmas program which was held on Sunday, December 19, 1982. Tommy informed [REDACTED] that several of [REDACTED] friends from school were coming and they planned to have a party. [REDACTED] asked our permission and, as usual, we asked who was going to be there and he said Tommy told him [REDACTED] and [REDACTED] and others. Therefore, we gave our permission.

On the morning of December 20, 1982 at approximately 3:45 a.m., [REDACTED] called home and asked us to pick him up. I asked what was the matter, and he said he wanted to come home. I, again, asked what was wrong, and he said he did not feel good and to please come and get him. I knew, from the tone in his voice, there was something else wrong, but felt I should get up and go get him right away. I told my husband, [REDACTED], about the phone call and he immediately got up and we both went to pick up [REDACTED]. When we arrived, he right away came out of Tommy's apartment and when he got in the car, he started crying. We asked him what was the matter and he said he just wanted to go home. However, we told him we could not leave until he told us what was the problem. [REDACTED] related in detail that Tommy Lewis had come to the couch where he was sleeping and made homosexual advances toward him.

When [REDACTED] finished relating what had happened, we turned around and went back to Tommy's apartment and confronted him with [REDACTED] accusation. He admitted what he did and said he was sorry and that he was sick. We left and started to go out and take a warrant, but decided to talk to our minister first. After relating the happening again, Mr. Morrison, our minister, suggested that we call J. B. Allen, Chief District Court Judge, member of our church, Emmanuel United Methodist Church, and a friend of our family. He came to the parsonage right away and [REDACTED] once again related what happened.

It was agreed that J. B. Allen and Rev. Morrison would meet with Tommy that morning at 8:30 in the church's study. Later we were informed that morning and he admitted to both of them what he had done.

Since that time, [REDACTED] has had a very hard time dealing with what happened and has had nightmares, guilt feelings and I guess embarrassment. I know that in time, he might be able to cope with this, but will not forget in a very long time.



On December 22, 1982 at approximately 9:15 AM I received a phone call from Mrs. [REDACTED]. Mrs. [REDACTED] started the conversation by saying she had some information about one of our Scouting volunteers, that she felt needed to be passed on to someone. She informed me that her son, [REDACTED] was not in Scouting, but that the volunteer in question was coming in contact with alot of boys in Scouting and in the church. She proceeded to tell the story that her son had told her. This is her story as per our conversation.

On Sunday night, December 19, 1982 [REDACTED] was invited to the home of Tommy Lewis and told that several of his friends from church would be there also. [REDACTED] agreed to go after evening church services with Mr. Lewis to his home, to find out that no one else was going to be there. At bedtime Danny was going to sleep on the couch. During the night, [REDACTED] was awakened by Mr. Lewis rubbing him on his back. At this point Mr. Lewis told [REDACTED] he could not sleep on the couch, so why didn't he come get in bed with him. Upon doing this, [REDACTED] was surprised when Mr. Lewis proceeded to take off [REDACTED] underwear. Mr. Lewis then proceeded to touch [REDACTED] private parts and pull [REDACTED] close to him and tried to kiss him.

At this point [REDACTED] called home and asked his parents to come and get him.

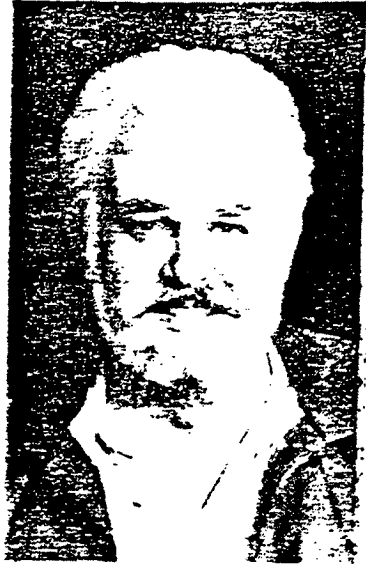
A citation accompanying the award said:

"This recipient gives much of his personal time to scouting and asks for nothing in return. This individual has been involved in scouting for many years as a boy as well as an adult. 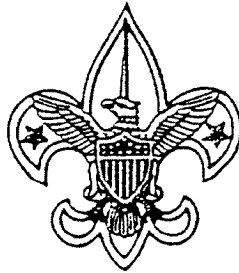
