Man charged in sex case found guilty, mentally ill

James M. Meyer, 35, of Woodson was found guilty but mentally ill on a charge of taking indecent liberties with a child as he appeared in circuit court Tuesday morning.

Judge Gordon D. Seator entered the judgement after he conducted a hearing to determine whether the defendant, who had been examined by a clinical psychologist, was mentally ill.

Meyer, represented by G. Ronald Kesinger, is accused of sexually molesting an 11-year-old boy in September or October of last year.

Meyer could be sentenced to prison from 4 to 15 years and could also receive treatment at the Department of Corrections' psychiatric unit. A fine of \$10,000 or two years of mandatory supervised release could also be imposed for a Class 1 felony.

Sentencing was set for 10 a.m. March 20 and Meyer was remanded to the custody of the sheriff.
