Dear Sir:

A situation of grave concern  
has come to my attention, that  
requires your immediate action.

I have been advised that a  
man recently released from  
the North Dakota State  
Penitentiary in Bismark, North  
Dakota, is now serving as a  
Boy Scout Leader. His  
conviction was for child  
molesting after being found  
guilty of sexual abuse of a  
young boy entrusted to his  
care under the "Big Brothers"  
program. It came out during  
the trial that this had occurre  
~~ed~~ on numerous other occasions

with other young boys. He was released from the above penitentiary around June 1984. A person with this type of record should not be allowed to assume a position of trust such as that of a Boy Scout Leader.

The person of whom I am speaking is Thomas W. Kreschel. His address is 4419 Wothan, Edmondson Terrace, Missouri. Phone: 428-1837. I do not know the troop number, nor whether or not the troop is in Edmondson Terrace. I do understand the troop is 10-12 year olds (which, incidentally, is the approximate age of the child he molested in North Wakarusa).

I thought you needed to be aware of this situation in order to take the necessary actions. My intent is not to cause trouble for Mr. Kreschel, but rather to look out for the

welfare of innocent and unsuspecting children. My daughter has been in Girl Scouts for four years and I would not want her in the care of a person with that type of background and record.

I know he has paid his debt to society and is now gainfully employed in the community but, however, it is for his own good as well as that of the children that he not be placed in a situation of temptation. His Counselor at the prison advises him not to expose himself to this type of situation. Due to my close association with this individual, it is necessary that my name remain anonymous. I would also request that this letter not be shown to Mr. Krechel or his ex-wife, as my handwriting

would be recognized. The above information may be verified by contacting the North Dakota State Penitentiary in Bismark.

It is my fervent hope that the next thing I hear in reference to this situation is that Mr. Kreckel has "given up" his association with the Boy Scouts.

It is also a concern of mine that a national police check isn't run on people to whom our children are entrusted in these organizations. I feel that every precaution should be taken to see that these types of people are not able to get into these programs. I beg of you to give this late matter serious consideration.
