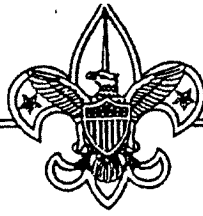


Gentlemen;
