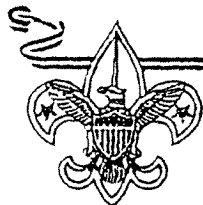

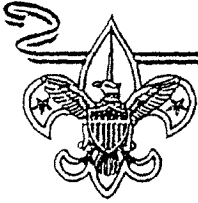

STATEMENT OF THE PARENT OF [REDACTED]

We, the parents of [REDACTED] and [REDACTED] member of the [REDACTED], make the following report of [REDACTED] description of improper conduct toward him by [REDACTED] scout leader in the [REDACTED], including our impressions of [REDACTED] suddenly changed attitude toward [REDACTED]. [REDACTED] report is written in notes taken as he talked, and all statements, though in the third person, are his own and would be verified by conversations with him, though they are placed in the third person in the following statement.

On Friday, January 9, 1976, [REDACTED] rode to Camp Manle Bell with [REDACTED] and [REDACTED] a scout, in order to sleep over and prepare the camp for the "Freezerie" gathering of scouts the following day. Each of the two boys with [REDACTED] had their own gear, and at some time before that night, apparently on the drive from Provo to camp, [REDACTED] suggested that they ought to zip bags together and sleep together in order to stay warm.

Most of the staff that night slept in the Pavilion, which was the understanding of the two boys, but [REDACTED] talked them into sleeping in his tent up at the Horse Pasture. He gave as a reason that people would be going in and out all night in the Pavilion, and the hinges on the door there would keep them awake. So they took their gear to the Horse Pasture, dug in their tent in the snow, and left their bags unopened in the tent while the three went down to the Pavilion for dinner. There it was decided that the staff scouts would take turns on snow watch over the igloos of other scouts sleeping over that night, to be sure that there were no cave-ins or other problems. [REDACTED] opted for the first watch, since they did not want to settle in and out of a crowded three-man tent.

After this assignment, [redacted] and the two boys walked back to the tent, and the boys got their flashlight to take their first watch, from 11 p.m. until 12a.m. While on patrol, [redacted] arranged the sleeping bags, and [redacted] observed the next mornin that he had zipped two of his own together, not using a bag belonging to either boy. When the boys returned at ¹² 1 a.m. [redacted] was still awake. [redacted] showed some hesitation on what part of the two-bag arrangement to sleep, and [redacted] instructed him to take one side, [redacted] the other side, with [redacted] in the middle. [redacted] was clothed for sleeping in his shorts, long johns, and a turtle neck sweater. They went to sleep about 12:15 a.m.

[redacted] went into a deep sleep, and between 1 and 2 a.m. was awakened by [redacted] stroking his leg about 6 inches above the knee. [redacted] was lying on his back as he awoke. He was confused by this and subsequent actions and said nothing—and reports that [redacted] said nothing in this or the subsequent episode. After stroking his leg for 2-3 minutes, [redacted] then reached above and pulled down his [redacted] long johns and shorts from his waist to just below his genitals. [redacted] pulled at one side, and then the other to accomplish this result. At that point [redacted] used both of his hands, the one manipulating [redacted] testicles and the other stroking [redacted] penis. He fondled [redacted] this way for 5 minutes. [redacted] first produced an erection in [redacted] with his hand, and then [redacted] took his thumb and forefinger and moved to a stroking action up and down the length of the penis, masturbating [redacted] with this method, periodically drawing his thumb over the end of the penis. [redacted] tried to think what to do and realized that [redacted] was attempting to effect an ejaculation. Before this happened, [redacted] broke contact by rolling over on his side, with his back toward [redacted] and [redacted] pulled up his shorts and long johns.

After this experience [REDACTED] dozed off on his side, the position just described. In about another hour, [REDACTED] estimates, he waked again, on his back, with a repetition of the identical incident. First [REDACTED] stroked his leg, then he pulled down his clothes again, then [REDACTED] used both hands in the same way on [REDACTED] genitals. This second experience was broken off again by [REDACTED] with [REDACTED] attempting to induce an ejaculation and [REDACTED] turning on his side with [REDACTED] back to [REDACTED] again before this could happen. The total time of the second episode [REDACTED] estimates at 2 minutes.

[REDACTED] did not sleep much the rest of the night, disturbed and apparently angry with [REDACTED]. He dozed slightly but waited for morning, and at 6 a.m. got up with [REDACTED] and went down to the Pavilion for breakfast. [REDACTED] kept minimal contact with [REDACTED] that day, and inquired concerning going back with others, but went back with [REDACTED] as the only option. [REDACTED] acted as if nothing had happened during that day and on the way back home. [REDACTED] attempted to choose a topic of conversation that was neutral, their common interest in electronics and how he could hook up circuits in his room with his new stereo.

[REDACTED] said nothing to anyone about this incident, and then only mentioned it privately to his parents. His normal pattern was to talk of the experiences of camp, but he did not do this after this camp. In a few days, when he was very discouraged, his mother indicated that many liked him, including [REDACTED] angrily answered, "I will never do anything with [REDACTED] again."

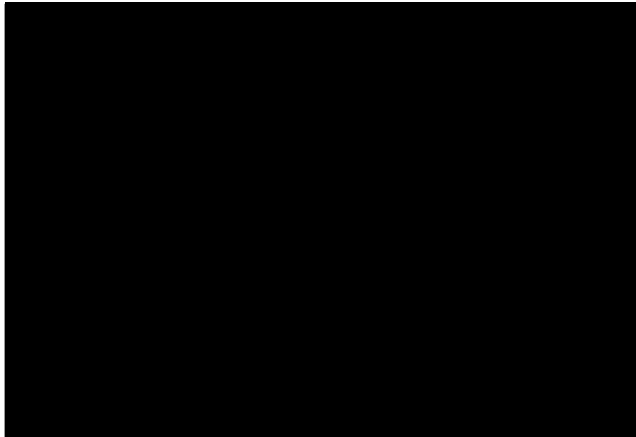
[REDACTED] had taken [REDACTED] earlier to Salt Lake and introduced him to KSL equipment and the computer. [REDACTED] liking for adults was headed by [REDACTED]. Suddenly, and for no other reason than the above episodes, [REDACTED] became a person that [REDACTED] was disillusioned with. This has not happened with anyone else, to have [REDACTED] suddenly turn around in his feelings. It is

apparent to us as his parents that only a highly negative incident like the above could cause this sudden reversal of [redacted] feelings. Yet [redacted] remembers the pleasant times with [redacted] and the scouting information that [redacted] gave with appreciation. [redacted] did something very severe to bring this^{re}/action in [redacted]. Furthermore, we have questioned [redacted] over a period of several months, to find that [redacted] story is highly consistent, and our experience with him is that he will be strictly honest when questioned seriously on any matter.

something like I was cold last night, and then he didn't say anything but I wish he would have. He also asked me if him rubbing my back bothered me I said "well I'm trying to get to sleep" then he stopped and a little while later - after I just lay on the bed thinking of what he was doing

I got up because I was feeling sick and got a drink. I think

it was the turmoil inside me of thinking about it, that made me sick.

I checked the time it was about 5:45 so I got in bed.

(I found out later that my dad had woken up at about 5:00 AM and was praying very hard for me.)

A little while later he put his arm around me and hug me and I got up and looking ~~at~~ at the wall said, "What is this a Radio?" and I turned it on a few places then turned it off.

After a while he asked me if
