## Scout assistant gets term in '76 rape of city boy, 11

An assistant scoutmaster who pleaded guilty last year to raping an 11-year-old member of his Boy Scout troupe was sentenced today to one year in the Hennepin County Workhouse work-release program.

water Prison on the criminal sexual conduct charge, said he was impressed by Koski's cooperative attitude and his willingness to change his behavior. The work-release sentence means Koski can keep a job during the day, but must stay at the county facility at night.

Hennepin District Judge David R. Leslie also ordered Martin Ronald Koski, 31, to participate in a rehabilitation program for sexual offenders after four months of court-ordered psychological evaluation.

Koski pleaded guilty last Dec. 28 to the rape of a Minneapolis boy who was helping him move furniture into Koski's apartment at 3104 Dupont Av. N. Koski had been an assistant scoutmaster for seven months at the time of the rape.

Leslie, who could have sentenced Koski to up to 20 years in Still-

## Boy scout leader admits raping 11-year-old member of his troop

An assistant boy scout master pleaded guilty yesterday in Hennepin District Court to criminal sexual conduct in the first degree.

Martin R. Koski, 31, admitted raping an 11-year-old member of his scout troop when the boy was helping him move furniture into

Koski's apartment at 3104 Dupont Av. N.

Judge David R. Leslie ordered presentence investigation and sentencing for Jan. 26. A second charge, sodomy, was continued that date.

Koski, who could be sentenced to up to 20 years in prison, court admitted both oral and anal penetration but did not say when Leslie asked him if he had anything more to say.

According to police reports, Koski had been an assistant scout master for seven months. His wife and children were out of town at the time of the incident, the formal complaint said.
