This statement is regarding three occasions when Richard Woods, approximately 45 years of age, made sexual advances toward [redacted] age 15.

The first attempt was at school camp in 1970. [redacted] was a first year camper (13 years of age).

Mr. Woods came to [redacted] tent after dark. He told [redacted] and his tent partner: "You know, what we do in here is just between us". He was wrestling on the cot with [redacted] roommate when he approached [redacted] cot and fondled [redacted] under the covers. [redacted] was very upset and told one of his scout leaders. The leader stated he would talk to Mr. Woods and told [redacted] not to tell anyone.

The second occasion was in Mr. Woods' home in November, 1973. Mr. Woods is a merit badge counselor. [redacted] was telling him of being in the hospital on his vacation. Mr. Woods told [redacted] he had had a hernia operation and he took down his pants to show [redacted]. He then proceeded to masturbate [redacted].

The third occasion was March 5, 1974. Mr. Woods asked [redacted] to come aboard and talk about being on staff at camp. Mr. Woods had called many times asking [redacted] over and inquiring about him. His parents kept telling him he would be hurt Mr. Woods' feelings if he didn't go, therefore [redacted] went over to his house this third occasion and Mr. Woods repeated his sexual advances toward [redacted]. [redacted] returns home and with great humiliation told his parents.
