Suspect was apprehended shortly after victim made complaint. Victim's mother was advised and suggested we interrogate suspect before any police action is taken. On March 9, I had a conference with the suspect and his father, and I was assured that the suspect would be submitted to a psychiatrist for psychiatric examination and his progress would be reported to me. I contacted the victim's mother the same date, and advised her of my actions, and she completely concurred and stated she did not wish to prosecute.
