I [redacted] age 11 of 422 Timberline drive Rancocas woods do here by make the following statement of my own free will and accord, with out any fear threat or promise of reward. Have been advised that I do not have to make a statement unless I care to do so, Have been advised that any thing I say may be used against me in court.

[redacted] I am chief Panarello of Mt. Laurel Township Police.

- Q. [redacted] will you tell us what has taken place between you and Mr Dyson ?  
A. Yes  
Q. Do you go to school and where ?  
A. Yes I go to school Fleetwood in the 5th grade.  
Q. [redacted] tell us what happened with you and Mr. Dyson ?  
A. About a year ago I was at his house and Mr. Dyson asked me to go in his bed room, He took off his pants and told me to take my privetas out, I did not take it out so he pulled my zipper down and took my penis out he had his under shorts on and took his penis. He started playing with mine than my hand on his and started moving it back and forth. Than he started to tell me how to get a baby. I listened for a while than I said I had to go go home and left. About a month later I was at his house and he asked me if I wanted to camp out with him, I said yes I have to go home and get a blanket and pillow. When I came back he was already out in the woods and had the tent set up. I got my stuff in the tent and laid out my blanket and pillow. Than he asked me if I wanted to go swimming, I said yes and [redacted] was with us. Than we went back to the tent we had some coffee sat by the fire and talked for a while. Than Mr Dyson and [redacted] went night swimming and I went to sleep. The next thing I knew Mr Dyson was beside me say [redacted] are you asleep. Than he put his hands under my blanket and in my pants and started playing with my penis. Than he pulled down his under pants and put my hand on his penis and moved it up and down.  
Q. How many times did this sort of thing happen ?  
A. This happened about seven times mostly on camping trips.  
Q. Why didn't you tell your mother or father ?  
A. Mr. Dyson told me not to tell any body and I was scared to tell. But to day mother was reading the bible and said some about evil and I said Mr. Dyson was an evil man. Than my mom took me in the bed room and I told her what mr. Dyson # had done.
