Following our numerous conversations and the materials that you provided to me, I have met with Frank Tanger and he has extended his resignation from Scouting in any capacity. While he felt that some of his actions were misconstrued, he did not feel that he could justify them, and thus elected to resign. His name has been placed in the confidential file with the National Council in New Brunswick.

May I urge that discussion of the matter be terminated immediately, and that it be kept as confidential information among the small number of persons currently involved. I feel most strongly that in the best interests of Scouting and Frank himself that this should be a closed issue from here on.

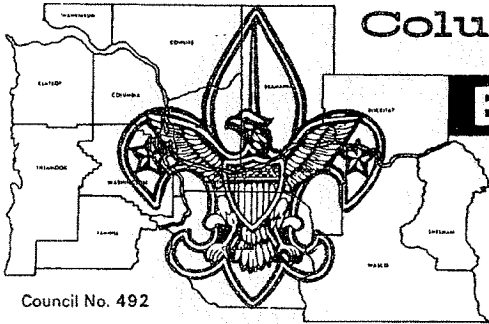

He had me play strip poker with him in the vault at the Clackamas county Court house. After he had me stripped and then put his hands all over me. then he let me get dress.

While with Frank TANZER work on some scouting material to be mailed. He ask me to play a game called (Get the message through) at first it was simple then he ask me if he could show me a place to hide a message. I said yes so he took my pants down and place his hand at the cress of my thips then I pulled up my pants.

While working on a service project with Frank Tanzer (Citizenship in the community) the subject of pressure points was brought up by him, in doing so he made me strip and also he stripped (taking down his pants) (and underwear)

Earlier in the same day he showed me ~~pictures of~~ nudist colony magazines.

Two weeks before this he got me to play strip poker with him in the vault at the Clackamas county court house, this was in the evening when nobody was around.

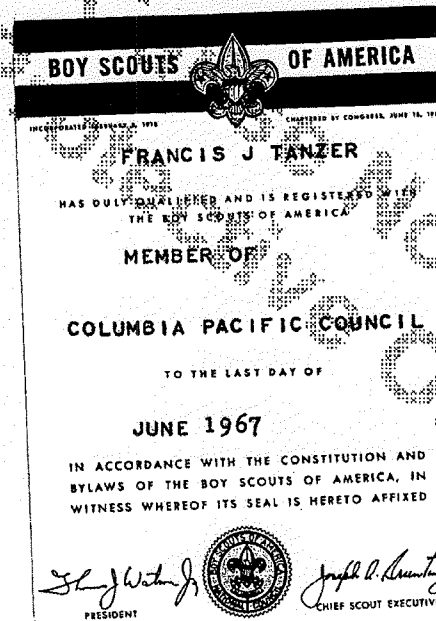

