I have been asked by Mr. Starkey, chief executive of the Dan Beard Council to state my recent experience with Mr. Guy Collins, Scoutmaster of troop 920, Hamilton, Ohio.

On July 18, while members of our troop were distributing advertisements in Mr. Collins' area, he invited me into the basement of his home and expressed excessive affection toward me by hugging and kissing me and opening my zipper and fondling the area inside. This lasted for one-half hour. I thought about running away but was too nervous and upset.

On one previous occasion on a fishing trip several months previous to my last experience, I had a similar experience. His affection toward me started at Camp Myron Kahn in the summer of 1963, when he kept me up late at night in his tent helping me to pass advancement tests and hugging me. I didn't realize it
