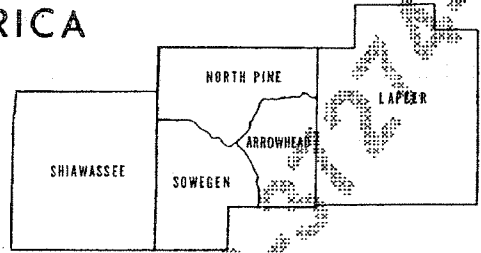

The information you have provided will enable us to identify Mr. Kubic should he ever again attempt to register in the Scouting program.

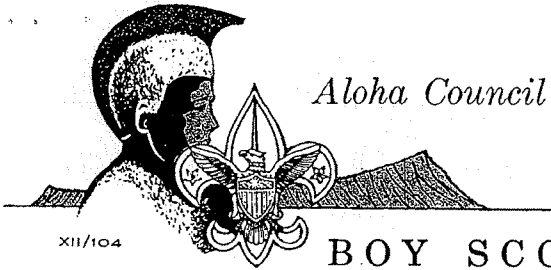

Dear Howard:

Recently the United States Navy dishonorably discharged Jerome Kubic. He was formerly attached to AEW BARRON PAC, Barber's Point, and served as assistant scoutmaster for Troop 121, sponsored by the United States Naval Air Station at Barber's Point. He was discharged following confinement at Tripler Army Hospital and at the conclusion of his investigation by the Office of Naval Intelligence.

At one time Kubic admitted to be a homosexual, but later denied admission. His activities have been questioned by some parents related to the Scout Troop. Description is as follows: 21 years of age at the time of registration on October 31, 1964; he is a Catholic; 5 foot 9 inches in height; weighs about 160 pounds; has sandy hair and blue eyes; and is single. It is believed that he came from Michigan but is last known to be living in California.

My recommendation is that this individual should not be allowed to register in Scouting. If it is necessary to go further than this letter and you want some sort of statement from the Office of Naval Intelligence, please let me know and I will try to obtain further proof.
