Two volunteer leaders of this council have been relieved of their Scouting responsibilities and should be placed on our confidential list pending outcome of investigations and legal actions.

This man is out on \$4,000 bond awaiting action of the Grand Jury. He has 2 charges, thus far, of molesting a minor. He admitted to the District Executive serving the area that the charges are true. He is a Civil Service employee of Robins Air Force Base. The Base will review his case on August 23. His felony trial will not come up until later in the year provided the Grand Jury indicts.

CLARENCE A. FRANKLIN Route 73, Joan Drive, Macon, Ga.
Former Scoutmaster, Troop 120, Warner Robins

Prompted by an "unofficial" call from the Base, Sgt. Franklin was replaced by the Troop Committee as Scoutmaster several months ago. He is a career man with more than enough time to retire from the service. We understand he is undergoing psychiatric treatment prior to his "retirement" from the Air Force. Our sources say that the type of separation certificate will be sufficient proof of his undesirability as a leader of boys. I gather that sources available to you will justify his being placed on our confidential list.

Please let me know if there is any other information necessary or if there is anything else I should do.
