Dear Paul:

The reason that I did not respond to your earlier letter is there is not too much more to add to my initial letter.

There is one correction. He is employed by the State at the Fernald School in Waltham, Mass.

As to amplification of the offense, suffice it to say that he engaged in sexual acts with one of our scouts, [REDACTED] Mass. age at the time 12 years 4 months.

There are no police or court records or statements.

There is a new law in Massachusetts this year which makes it a criminal offense subject to a fine for any doctor, teacher, policeman, professional etc. knowing of a child abuse case and not reporting it to the state.

For that reason and also the family's wish to keep it quiet we have handled it in this manner.

This should be sufficient for the file in this case.
